Pursuant to state law and regulations, the San Francisco Fire Department (SFFD) requires that contractors installing, repairing, inspecting or testing any life safety equipment in San Francisco including, but not limited to, fire alarms, standpipes, and sprinkler systems, must possess a valid current C-10 (electrical) or C-16 (fire protection) contractor license issued by the California Contractors State License Board (CA-CSLB).
